SUPERVISOR COMMENTS

Officers contacted a male asleep behind the wheel of a vehicle in the roadway. After a DUI investigation the officer determined the male was not intoxicated, just sleepy. He had an outstanding warrant and was taken to jail. Another officer recognized a male standing in front of a closed business. The officer knew the male had a felony warrant for his arrest. The male was contacted and taken to jail for the warrant. Later in the shift all officers responded to a burglary in-progress at Dutcher Middle School. A witness saw three males breaking windows at the school, then run from the scene. When officers arrived in the area three intoxicated males (one adult and two juveniles) were located and stopped. After checking the damages at the school, it was determined that the males had broken into the restrooms and caused significant damage inside the restrooms, including water damage from overflowing toilets. A broken window to a building was also located. All three were arrested for second degree burglary. The juveniles were booked into juvenile hall and the 18-year-old was booked into jail.
